Additionally, she holds a Master's degree in Hospital Administration. She is also a Board Director at MMG Aklan Specialty Clinics and leads the Department of Obstetrics and Gynecology at Saint Gabriel Medical Center. Dr. Icamina is a published researcher with awards for her work in reproductive endocrinology.
